1. Welcome/introductions

AMB welcomed attendees to the meeting and to Brussels.

AMB presented information about the background of Belgium and the culture [see attached].

2. Update of Children's Nursing in Belgium

See attached presentation from AMB about Paediatric Nursing in Belgium. Developments highlighted in relation to patient satisfaction tools, minimum data set, clinical leadership, care program for children [75% of nurses have to be paediatric nurses in paediatric units] includes facilities required i.e. play rooms, parents accommodation.

NVKVV – professional organisation

HV advised that there are about 60,500 nurses in Belgium. The Government is setting up a registration scheme. There are 5 professional organisations in Belgium. NVKVV have 8,500 members. Paediatric Nursing Association sits within NVKVV. Education centre within NVKVV. NVKVV hold annual congress for 3,000 nurses, includes a paediatric programme.

4. Evaluation of IPA/IPAN Congress in Greece, 2007

Formal written evaluation post Congress from ED discussed. Congratulations extended to ED and conference planning team. Issues discussed in relation to time of the conference and number of attendees. IHD highlighted discussion with paediatricians about future IPA congress.

7. Paediatric quality indicators and satisfaction tools

Presentation from FS about the findings from the survey [see attached] The Aim is to identify minimum quality indicators that a country should measure to ascertain quality of neonatal and paediatric services in their country. Different countries had interpreted questions differently. Attendees discussed the way forward, including the need to ensure the final list is relevant and applicable to all countries.

8. European Federation of Nurses Associations

Paul de Raeve General Secretary of European Federation of Nurses Associations attended the meeting to discuss issues and ways of working. EFN has various priorities including education of nurses, workforce planning, health services and patient safety.

EFN consists of 30 member states/professional nursing associations. Some of the professional nursing associations also have a trade union function i.e. Royal College of Nursing in the UK, while others also have a regulatory perspective i.e. Spain and Portugal. Governance of EFN is via a General Assembly of representatives from the member states professional nursing associations. General Assembly meetings are held twice a year. ESNO has 3 seats on EFN

EFN is affiliated to ICN and has links with FePI. Primarily though the majority of activity centres around working with, influencing and lobbying the EU Parliament and Commission officials [see attached map of links].

- Educating parents to do nursing care what is needed?
- Difference in care being provided by paediatric nurses and general nurses?
