Who cares for children?

Nurses working with children and young people have a specific nursing qualification in paediatric nursing?

YES = 13.5


NO = 10.5

Some indicated that there would be a programme in the future and so answered yes and no

Paediatric Nursing register?

- **There is a national register of paediatric nurses**

YES = 14  **NO = 10**

- **A nurse has to have passed a specific paediatric nursing course to be registered as a paediatric nurse**

YES = 16 **NO = 8**

How paediatric nurses are currently educated?

3 Options

- Education to qualify as a general nurse only
= 8
- After qualifying as a general nurse completes additional paediatric nursing education to be recognised as a Paediatric Nurse **= 14 (+3)**
- General nurse training with at least 12 months specific paediatric training as part of first nursing qualification **= 4**

Level of education programme

» Certificate = 5

» Diploma = 8

» Degree = 4

» Masters = 7

Length

- 1 module (ECTS 30)
- 1 year (post registration) (90 credits, 3 semesters)
- 2 years (post registration– incl. Masters)
- 3 years
- 4 years

Content - theoretical

Hours = varied (100-2,300 hours)

Knowledge of

- nursing, paediatric nursing and nursing and health sciences
- natural sciences and medicine
- humanities and social sciences
- law, politics and economics

Content – practical

- Hours = varied (120 - 2,300)

Students can practice in the 5 paediatric nurse areas :

- neonates
- maternity
- maternal and infant protection (community health)
- nurseries
- paediatric wards
