Family paediatric nurses have ...

- additional resp. expanded competences in health promotion and prevention
- **expertise in different workings areas, e.g. in early prevention**
- **the competence to develop concepts, e.g. for a "healthy start in life" according to the "Health 21" policy framework for the WHO European Region (1998)**

"Family Paediatric Nursing"

- **2009 BeKD e.V. and IG Kikra designed a curriculum for "Family Paediatric Nursing" (FGKiKP)**
- increasing need of support-systems and counselling due to changes in the society and in family life
- increasing demand for special competences of paediatric nurses

Early prevention and child protection in Germany

- Child protection and safety acts in every "Bundesland"
 - 2007 National Centre on Early Prevention (NZFH)
 - 2012 national Child protection and safety act
 - 2012 National Initiative on Early Prevention 2012 - 2015
- ➔ protect children against dangers earlier and better by **networking the assistance provided by the health system and the child and youth welfare sector** as effectively as possible

National Centre on Early Prevention (NZFH)

- BeKD is a member of the advisory board of NZFH
- **coordination of the implementation of the national Child protection and safety act into (local) practice (National initiative ...)*** (**www.fruehehilfen.de*)
- **qualification**
- definition of qualifications profiles for professionals, e.g. "family paediatric nurses" and "family midwives"
- **development of multiprofessional networks**
- **quality assurance**
- defined qualifications as condition precedent for getting money for the work by the authorities for health and social affairs

Curriculum "Family Paediatric Nursing"

- focus on **early childhood intervention (early prevention) and child protection**
- post-graduate training
- prerequisite:
title "Paediatric Nurse"
(in Germany: direct entry qualification)
- 280 hours
- "certificate of training"
