#### Estonia Congress Update -

# PNAE website/s (RCN to FNOPI) & proposed new PNAE logo – Presentation from (IDO)

IDO demonstrated the new PNAE website which is hosted by the National Federation of Nursing Professions Orders of Italy (FNOPI) and presented details of a range of possible new PNAE logos.

Discussion following the presentation focussed on the hard work and effort, led by IDO, that had gone into producing a bright, clear, user friendly website and choice of suitable logos.

PNAE members positively approve of the new website and asked whether the PNAE webpage at the RCN will directly signpost the link to the Italian website.

If PNAE items are uploaded and available on RCN webpage for information, this will cause duplication and confusion.

Documents from the RCN webpage to be sent to IDO and Fiona Smith (FS) to be contacted regarding pre 2014 PNAE information.

#### **Action Point**

JD will contact FS regarding the location of PNAE documents prior to 2014 that are missing.

PNAE members to let IDO know if any items are missing from the new website and of any new items they would like added.

The <a href="https://pnae.eu">https://pnae.eu</a> weblink only should be available on the RCN, PNAE webpage to direct people to the new Italian website.

Members asked why pnae.eu and not PNAE and were advised that pnae.eu is the only domain available.

**New PNAE logo:** members reviewed the style and colours of proposed PNAE logos and a clear decision was made that 7B was their preferred choice.

Some improvements could be made to the definition of the hands within the logo and members were asked to think about the colours used and effective they would look when photocopied.

IDO and colleagues were again thanked for all their hard work and time spent on the design of the new PNAE website.

# Workforce and recruitment - KdW Belgium

This work is unable to be progressed by KdW due to her new work commitments. KdW will make arrangements with colleagues to continue the work.

# **Advanced Nursing Practice - IDO Italy**

75% response from PNAE members to survey. Difficult topic due to wide range of variation in the definition of Advanced Nursing and the roles of Advanced Nurse Practitioners. This item will be discussed again at the October meeting.

Shared Record Keeping – Slovenia? Plus IDO/KB/BP/JD (See previous minutes) This work is not being progressed.

## Early Warning Systems - CS - Ireland

CS and OG involved in this work. OG will progress and include PNAE in a survey being undertaken by Hugh Chapman from the European Foundation for the Care of Newborn infants (EFCNI) and a report is due in the Autumn.

# Safeguarding – KV – Belgium

There will be recognition in this work of the impact of COVID-19. Volunteers required to help and offers received from Catherine and Ingrid.
