1. Nursing in Belgium: President Ellen de Wandeler, Katrin de Winter and Karen Vansteenkiste welcomed everyone and gave excellent and interesting presentations about nursing in Belgium. The emphasis is on working together as done by the Nurses Association from Belgium (https://www.netwerkverpleegkunde.be/) and being sensitive to the languagues spoken by the population of Belgium, Flemish, French and German.

A law was passed in Belgium on the 22nd of April 2019 regarding the quality of healthcare practice and the standards of nurse training required to comply with this legislation. Moreover the law described the legal framework of the Verpleegkundig Specialist (VS)/ Infirmier de pratique avancée (IPA) and it is in Belgium an important step forward in the evolution of the nursing discipline in general, and the recognition of Advanced Practice Nursing specificity.

- Impact on children and families of the war in the Ukraine
- Ongoing impact of COVID-19 disease and Long COVID on children and families

The PNAE members discussed the previous matters arising: the general problems are very similiar among all the countries. The work load and workforce within paediatric settings are issues which are crucial for almost all the countries. The problems are not only related to the Coronavirus Pandemic and COVID-19 restrictions, but were also identified previously. The resources allocated to the healthcare systems and to the Nursing Profession were inadequate and left nurses feeling undervalued. A solution to the problem for many countries is to recruit nurses from developing countries without considering the professional education and the cultural and language differences within this workforce. This could present a risk to patient safety and the quality of nursing care especially to the paediatric population. Moreover, there is an ethical issue regarding the risk of depleting the nursing workforce in the developing countries and leaving the populations without safe and approropriate nursing services.

PNAE agreed to provide a position statement on this issue which will assist the members of each country to explore their relevant local policies.

- Jane Coad informed PNAE colleagues about the meeting she had with European Area WHO about long COVID in children.
- Another issue arose regarding the risks to the protection of the migrant paediatric populations from Ukraine and other countries where
 war and conflict are present. The poor economic, social and health settings add to the current risks of harm for children and their
 families.

4. PEWS utilisation in paediatric hospitals in Europe, a collaborative survey with ESPNIC and PNAE- OG

Early Warning Systems – Update on the work being undertaken regarding Early Warning Systems available for use in European hospitals.

A survey was undertaken from September 2021 to April 2022 and 197 responses were received, the final results are due in December 2022.

The participation of PNAE members in the survey was discussed and the members who facilitated the collection of the data will be cited as members of the research Group and will be acknowledged in the future report. It appears that PEWS is still not universally utilized in Europe and an analysis will be undertaken in the future regarding PEWS utilization across the European regional area.

5. **Members' suggestions for future research** – The members discussed possible topics for future research: Impact of long COVID in children; The children's nursing workforce, advanced practice in paediatrics, drawing on the qualitative data PNAE collected in 2021.

6. PNAE work schedule: Proposals and Updates

Each country provided an update on their current work and children's nursing services.

7. Any other business

- Update and synthesis on MOCHA recommendations: the main results of MOCHA study and recommendations were presented (slide available on the PNAE website). The PNAE members agreed that Immacolata will contact Maria Brenner who previously presented the European project (30th PNAE meeting in Iceland) in order to evaluate the possibility and opportunity to provide any update. This may assist PNAE members to discuss and explore the role of the paediatrician in the community setting and the value of co-working and the support of paediatric nurses.
- Update on the impact of long COVID on children and their families, Jane is attending key meetings and will keep PNAE updated on progress
- Impact of workload on the workforce, nurses are experiencing exhaustion and stress: A discussion followed the presentation on this topic and all members expressed concern regarding these issues. PNAE members can access the link to the UK RCN survey; Nursing Under

The survey is available to PNAE members, and they can provide feedback on the issues they wish to explore in more detail at the next meeting. The PNAE vision for the children's workforce will be discussed along with how to improve university recruitment of students to the children and young people's Bachelor of Nursing and post graduate degrees and specialization.

- Update on the survey of Paediatric Sepsis recognition across Europe; (Catherine Sheridan could not participate at the meeting and the issue will be re-presented at the next meeting).
- Resources and information packages for children and families, nurses, aid workers and volunteers impacted by the war in Ukraine; There are several resources identified by PNAE members and it was agreed that it would be very difficult for PNAE to collate all the information. Relevant resources are already accessible from many websites (e.g., the World Health Organisation and UNICEF). PNAE members concluded that members from each country will signpost their colleagues to the most relevant resources for their services and their staff who care for children and their families.

- Autumn 2023 Rome, Italy, 28th and 29th of September, includes the 6th PNAE Congress. On 27th of September, PNAE meeting.

Immacolata updated PNAE members about the organization of the 6th PNAE Congress in Rome in September. The topics have been shared (will send to the PNAE members again by email), the composition of Scientific and Organizational Committees will be confirmed. The Italian Federation of Nurses (FNOPI) is arranging all the organization and a local Organizing Committee is agreed. Wednesday 5 October 2022

On the morning of the 5th of October, PNĀE members were pleased to hear two interesting presentations from two advanced nurse practitioners from Belgium. The first presentation was from Meike Caelen who discussed the strategies and interventions for the prevention and reduction of pain and discomfort in children undergoing clinical procedures.

The second item was presented by Renke Peeters, Nurse specialist in paediatric oncology at University hospital, Antwerp. Renke discussed a project for the Patient record optimalisation for patients within the complex setting of Onco-haematology care.

PNAE members are very grateful to Renke and Meike for organising the presentations and for sharing their important and innovative practice with the group.

During the afternoon, PNAE members visited the Mother-Child Department of the General Hospital in Bruges. This hospital is in a new building (2019) and the neonatal and paediatric units are implementing innovative practice, for example, the designated, comfortable distraction room to assist children to cope with painful or distressing procedures. PNAE members were able to discuss clinical practice and the organisation of services with colleagues from the hospital. The PNAE members who attended the hospital meeting were very grateful to all the staff within the hospital departments.
